Mousetrap

A major benefit of modern operating systems is that you don't need to install any drivers to operate standard components such as two-button mice.

But if your mouse doesn't work upon startup, the source of the problem typically stems from the mouse being disconnected, being connected incorrectly, or requiring the installation of the proprietary driver.

Besides checking your mouse connection, you can resolve many mouse problems by installing the latest drivers and software.

Before you visit the manufacturer's Web site, locate the make and model of your mouse to ensure you find the appropriate driver download. You can usually find the model, product, or serial number on the bottom of the mouse, and many wireless mice include this identification on the battery cover or inside the battery compartment.

If the movements of your mouse seem erratic or sticky, it's more often the result of a poor surface choice.

Internet Talk

This is the 95th "Internet Talk" article for *The Bug Report*, a publication of the Greater South Bay PC Users Group (GSBUG). Liz and I hope that you are enjoying the hot summer season.

McAFEE SITE ADVISOR

Before going to a Web site that you are not familiar with, try checking it out at McAfee *Site Advisor*. Here's how:
Go to www.siteadvisor.com/

Type or paste the URL of the target Web site into the 'Look up site report' box:

Click on the 'Go' button.

If you type in 'winantiviruspro. com' into the 'Look up a site report' box then you will get this warning:

DEFENDING YOUR COMPUTER FROM MALWARE

While in the midst of some normal Web browsing on August 8th, an ad for "Win AntiVirus Pro" appeared on the screen of Internet Explorer.

A split second later, a "Threat Detected" warning appeared from AVG Resident Shield, part of AVG Anti-Virus Free Edition: This warning message stated that AVG Resident Shield had dis-

covered the "Exploit.ani" Trojan on my computer. I clicked on the 'Heal' button.

AVG then notified me that "Object was successfully healed."

A split second later, the exact same "Threat Detected" message popped up again.

After a few more cycles of this, I realized that AVG *Resident Shield* could not remove the persistent re-infestation of my com-

puter by
"Exploit.ani."
It was now time for
"Plan B"

At this point, I pressed Ctrl + Alt + Del.

Then I clicked on the 'Task Manager' button.

(Note: See 'Task Manager' graphic on next page.)

Next, I clicked on "http://85.255.117.38" to highlight it:

Finally, I clicked on the 'End Task' button of the 'Windows Task Manager.

At this point, the problem went away and life was back to normal.



The moral of the story is you often have to use both your antivirus / anti-malware software AND the Windows Task Manager to rid your computer of harmful malware.

Also, never drag your mouse or click on any part of a Web page or pop-up that is provided by the bad folks, since doing so could cause something to trigger into your computer.

HARD DRIVE FAILURE

A GSBUG member asked Liz about what she can do to recover files from a failed hard drive.

I directed the unfortunate victim to an article entitled *Surviving a home data disaster: How Shirley got her files back.*

This long, informative article can be summarized as follows:

Pages 1 and 2: Defragment your hard drive(s) often to maximize the probability of recovering files when your hard drives fail. for you to ship the failed hard drive to a clean room lab that uses various heroic techniques to extract the data from your hard

Page 2: When a hard drive fails, remove it from the computer and set it up as a second drive on a working computer that is running the same operating system (i.e. same version of *Windows*). If and when *Windows* on this working computer assigns a drive letter to the failed hard drive, immediately remove the drive letter that is assigned to the failed hard drive to prevent *Windows* from writing to the failed hard drive.

Also, once a hard drive fails, never use it to boot up any computer, since the boot up process will probably overwrite sectors on the failed hard drive

Pages 3 and 4: With the failed hard drive connected to the working computer as a secondary hard drive, try to use various free software utilities to recover data files from the failed hard drive.

Then try the *EasyRecovery* software utilities at http:// www.ontrackdatarecovery.com/ which have both free and nonfree versions

Pages 4, 5, and 6: Try recovering files by using a professional service that remotely connects into the same computer that has the failed hard drive set up as a secondary hard drive.

Not mentioned: If professional services via remote connection do not work, the final solution is for you to ship the failed hard drive to a clean room lab that uses various heroic techniques to extract the data from your hard drive for between one and six thousand dollars

Both of these clean room operations have a good track record for doing the impossible for a sizable chunk of change.

Sometimes, freezing a hard drive in a freezer can get it to work

Goodsync provides you with a very efficient way to backup data files from one drive to another. By utilizing this software application, backing up your data files is so easy that you can back them up every hour, every day, or every week with very little effort.

Stop Printing That Document By Dave Gerber

Sometimes you begin to print a document and then change your mind. How do you stop a print job? Because your program simply passes off its printing jobs to Windows, there is no obvious way to cancel printing. It can be done if you're crafty, however.

Follow these steps:

Locate the printer icon located on document. Oh well. the taskbar at the bottom-right of your screen. (Look near the current-time display.) This printer icon appears only when *Windows* ready for more editing action. is sending something to the printer. Depending on how much you're printing and how fast your printer is, you may not even see it at all. If you don't, you're out of luck and you may as well quit right now and eat some ice cream

Double-click the little printer icon.

Cell Phone Mishap

If you drop your cell phone into a puddle, don't panic. Cell phones are tougher than they look.

Although most mobile phone manufacturers don't claim that their phones are water-resistant, many phones can undergo a quick dunk.

"The key is to minimize the time the phone is wet and the time the battery is on the phone while it is wet," says John Wernecke, spokesperson for Motorola.

"Remove the battery. Give it time to dry before replacing the battery. Some have reported that wrapping the phone in a thick towel to absorb liquid works very well."

In our own experience, we've found that phones often need as much as 48 hours to completely dry.

Once you've dried and then reassembled the phone, power it on and place a test call to make sure the phone works properly. If your phone displays problems (or doesn't power on at all), it's probably time to find a new phone.

Exploring Windows Explorer — part 2

This is part two of Exploring Windows Explorer with the idea of learning how useful this tool can be.

There are several ways to bring up Windows Explorer. Click means left click unless preceded by the word right.

In no particular order:

- 1- Click on 'Start,' hover the mouse pointer over 'All Programs' till the window with all options appears, click on 'Accessories' to open the subwindow, then click on 'Windows explorer.' On most machines, it will open with the 'My Documents' directory/folder highlighted and expanded.
- 2- Right click on 'Start' to open the options window, click on 'Windows Explorer.' On most machines, it will open with the Start Menu directory/folder highlighted and expanded. This is usually down four directory levels with the path - Local Disk (C:)/Documents and Settings/ (current user name for that machine)/Start Menu.
- 3- Click on 'Start,' on the default 'XP' menu, click on 'My Computer,' this opens Windows Ex*plorer* in the Task Pane mode. This is also true if you click on 'My Documents,' 'My Pictures,'

'My Music,' or 'My Network Places.' For most people this means navigating down a path one directory at a time, then backing out one directory at a time with the left arrow in the green circle. If you have followed the advice in part 1, at least you can see the path to where you are at in the address bar. Very few people that use this 7- Clicking on 'Start' and then mode make use of the history file provided by the little down arrows next to the left and right arrows. The history files can speed up navigation quite a bit, but in my opinion are nowhere near as efficient as having the Folders Pane visible instead of the Task Pane. Clicking on the Folders icon in the Menu Bar causes the full tree structure to be displayed in the left hand pane. That allows much more efficient navigation of the files on your disk(s).

- 4- Double click on the 'My Computer' icon on the desktop - takes you to the same place as #3.
- 5- Depressing either *Windows* key (the ones with the MS flag icon and the word 'Start' on them) and then tapping the 'E' key, opens Windows Explorer in the Folder mode with My Computer highlighted.
- 6- Depressing either Windows

key, and then tapping the 'F' key, opens Windows Explorer in the Search mode with the left pane asking, "What do you want to search for?" You then have the option of choosing several different categories of search including my most common choice - 'All files and folders.'

- 'Search' opens Windows Explorer in the same mode as #6.
- 8- Right click on 'Start,' then click on 'Search,' opens Windows Explorer in the Search mode with the left pane stating, "Search by any or all of the criteria below." This is the same location you end up at if you choose path #6 and then click on – 'All files and folders '

But wait, if that's not enough ways to open Windows Explorer, there's more!

- 9- You can make Windows Explorer part of the start menu with the following sequence: Start -> All Programs -> Accessories -> right-click on Windows Explorer -> Pin to Start menu.
- 10- You can put a Windows Explorer icon in the 'Quick Launch' portion of the Taskbar with this sequence: Right click

'Start,' click 'Explorer,' click on the WINDOWS folder, in the right pane, scroll down to explorer.exe and right click it, when the option window opens, click on 'Create shortcut,' place the mouse cursor over the new shortcut, depress and hold the right mouse button then drag the new shortcut to the Ouick Launch part of the Taskbar. Release the right mouse button and click on 'Move Here.' (place "quick launch.jpg" here) What!, you say you don't have a Quick Launch area — probably because the XP default for that feature is set to disable. You can fix that by right clicking on the 'Taskbar,' hovering over the 'Toolbars' entry till the options window opens, then click on the 'Quick Launch' entry to set a check mark next to it and enable that feature. Once the icon is in place, a single click on the Windows Explorer icon will launch it

11- You can put a Windows Explorer icon desktop with this sequence: Right click 'Start,' click explorer, click on the WINDOWS folder, in the right pane, scroll down to explorer.exe and right click it, when the option window opens click on 'Create shortcut,' then click and drag the new shortcut to the desktop. Right click on the shortcut icon you just created and when the option window opens, click on properties. When the properties window opens, click on the 'Shortcut' tab and edit the Target line to have Window Explorer open with the directory of your choice displayed.

This is an example of an edited Target line:

C:\WINDOWS\explorer.exe /e, / root,c: /select,C:\Documents and Settings\Jim.LIAN-LI\My Documents\NOCCC related files.

By substituting the path of your choice for the "C:\Documents and Settings\Jim.LIAN-LI\My Documents\NOCCC related files" portion of the above example, you can have *Windows Explorer* open and display the directory of your choice.

As noted in part 1, the default columns that are displayed in the *Window Explorer* detail view are: Name, Size, Type, Date Modified. But you should know that they are just four of the 45 possible column types.

Not all column types are pertinent for a given file type. For example, Bit Rate is not going to be very useful in a directory full of *.jpg or *.tif files. Camera Model is not very useful in a directory full of *.mp3 files.

As hard disks are humongous today, more and more people have large collections of pictures, video, music and Microsoft Office document files on their computer (and far too many are not backed up). The ID3 headers on MP3 files can provide a lot of information about each track. To easily see that information, you need to turn on more column details. You can not break anything by playing with these options. Click on 'View.' when the menu opens, click on Choose Details, (place "Insert Details.jpg" here)

click on an item in the list to place a check mark in the box which activates the feature, then click on a directory and look at the results. If you don't like the results, repeat the procedure to remove the check mark and it is gone.

The following is the complete list of possible column types: Name, Size, Type, Date Modified, Dimensions, Title, Date Created, Date Accessed, Attributes, Status, Owner, Author, Subject, Category, Pages, Comments, Copyright, Artist, Album Title, Year, Track Number, Genre, Duration, Bit Rate, Protected, Camera Model, Date Picture Taken, Episode Name, Program Description, Audio sample size, Audio sample rate, Channels, Company, Description, File Version, Product Name, Product Version, Profile, Width, Height, Duration, Bit Rate, Frame Rate, Sample Rate, Keywords.

NCSA is a go to resource for cyber security awareness and education for the home user, and small business, and education audiences. NCSA is a private partnership whose sponsors include the Department of Homeland Security, Federal Trade

Commission, and many privatesector corporations and organizations.

"The widespread availability of computers and connections to the online: Internet provide everyone with 24/7 access to information, credit, financial services, and shopping. The Internet is also an incredible tool for educators and students to communicate and learn. Unfortunately, some individuals exploit the Internet through criminal behavior and other harmful acts. Criminals can try to gain unauthorized access to your computer and then use that access to steal your identity, commit fraud, or even launch cyber attacks against others. By following the recommended cyber security practices outlined here you can limit the harm cyber criminals can do not only to your computer, but to everyone's computer.

However, there is no single cyber my computer while online, I saw security practice or technological solution that will prevent online crime. These recommended cyber security practices highlight that using a set of practices that include Internet habits as well as technological solutions can make a difference. The National Cyber Security Alliance's Top Eight Cyber Security Practices are practical steps you can take to stay safe online and avoid be-

coming a victim of fraud, identity theft, or cyber crime."

Here are the eight NCSA cyber security practices to stay safe

- 1. Protect your personal information. It's valuable. 2. Know who you are dealing with online.
- 3. Use anti virus software, a firewall, and anti-spyware software to help keep your computer safe and secure.
- 4. Be sure to set up your operating system and Web browser software properly, and update them regularly. 5. Use strong passwords or strong authentication technology to help protect your personal information. 6. Back up important files. 7. Learn what to do if something goes wrong.
- 8. Protect your children online.

Upon awakening after having once more dozed off in front of my personal data that confirmed I really did exist. I am alive! I have not been deleted! It was only a nightmare. I simply must stop watching those late night horror movies, kicking my computer in frustration, and improve my online security practices to avoid cyber fireworks.
